Project from the Capital Budget

#### **BACKGROUND & DISCUSSION:**

On November 9, 2022, portions of the Administration Building clay tile roof were damaged due to high winds. The Agency contacted its insurance provider, Special District Risk Management Authority (SDRMA), to inspect the damage and begin the claim process.

On March 1, 2023, the Agency solicited informal proposals for repair of the Administration Building clay tile roof. The Agency received one bid in the amount of \$92,700. It was decided to reject the bid and investigate replacement of the clay tile with shingles. During this time, staff discovered additional roof leaks that would not be repaired by SDRMA's recommended scope of work. There are several factors that contributed to the recommendation to replace the entire roof:

- Difficulty in procuring matching clay tile,
- Probability of additional damage due to high winds,
- Additional repairs not included in the SDRMA recommended scope of work,
- Difficulty in guaranteeing that all leaks are abated, and
- Preparation for solar panel installation to support the energy demands of the Replenish Big Bear Project.

On September 27, 2023, the Governing Board appropriated \$45,000 from the Contingency Fund, for a total budget of \$81,655.

On September 28, 2023, the Agency received one proposal from Rite-Way Roofing Corporation of Fontana in the amount of \$129,830.

The Agency is requesting an additional \$61,158 for the Administration Building Roof Replacement Project:

#### FINANCIAL IMPACT:

There are no additional financial impacts anticipated. The additional \$61,158 will be re-allocated from the Lake Pump Station Storage Building Rebuild project and savings from the Wash Press Headworks project in the Capital Budget. To prevent additional damage to the Administrative Building as a result of the missing roof tiles, the replacement of the roof is more critical than the Lake Pump Station Storage Building Rebuild. The Lake Pump Station Storage Building Rebuild will be deferred to a future fiscal year.

#### **RECOMMENDATION:**

Reallocate \$61,158 for the Administration Building Roof Replacement Project from the Capital Budget.
